### INVITATION FOR EXPRESSION OF INTERESTS AND PRE- QUALIFICATION FOR VARIOUS DEPARTMENT OF ELECTRICAL SERVICES RKN 12 PROJECTS ACROSS BRUNEI DARUSSALAM

#### TENDER SCOPE

The RKN (Rancangan Kemajuan Negara) projects represent the Government of Brunei Darussalam's national development initiatives, designed to strengthen and modernize critical infrastructure in line with the country's long-term socio-economic objectives.

Under RKN12, DES is undertaking a series of strategic power-sector projects that cover engineering activities, material procurement, work preparation, fabrication, site clearing, installation, and all associated construction works necessary to enhance grid reliability and capacity.

DES is exploring possibility of projects being packaged and delivered through a bundled approach to ensure better project control, improved schedule performance, and greater cost efficiency. Given the national significance of RKN initiatives, contractors are expected to demonstrate strong technical capability, robust resource planning, efficient execution strategies, and proactive risk management to ensure that all works are completed within the RKN12 timeframe, with final delivery targeted by 2029.

#### VENDOR ELIGIBILITY CRITERIA

##### **1. Experience**

- Vendors must demonstrate a successful track record of managing projects in delivering infrastructure projects of similar complexity and scale.

##### **1. Local Business Development (LBD)**

- EOI is open to all Companies that meets the requirement above.
- Interested Vendors may be required to comply to LBD requirements issued and requested by the Brunei Government.
- Specific targets for recruitment and development of suitably qualified Bruneian will be part of Tender.
- To increase spend in country either through full or co-ownership of capital assets for the purpose of the Contract between the local partners/joint ventures.
